Reporting directly to the Executive Director and serving as a key member of the senior leadership team, the CFO/COO ensures the organization has the financial discipline, operational systems, and data-informed processes needed to scale its impact.

This role blends strategic vision with hands-on execution, overseeing finance, budgeting, human resources, legal compliance, facilities, and day-to-day operations.

### **Key Responsibilities**

#### **Financial Leadership**

- Lead the development of annual and multi-year budgets aligned with BioBuilder's strategic goals.
- Oversee all financial operations including accounting, cash flow, reporting, and forecasting.
- Provide intuitive financial reports and insights to the Executive Director and Board of Directors.
- Ensure accurate and timely preparation of all audits, tax filings, and financial statements.
- Develop financial models to evaluate new programs, partnerships, and revenue opportunities.

- Oversee operational systems that support high-quality program delivery and staff efficiency.
